

"FROM THE BEGINNING . . ."

Few national classes can boast in their first year of existence a roster nearing the five hundred mark and spreading from the Atlantic to the Pacific coasts. Yet that is the record of the Penguin Class Dinghy Association which, with the publication of this handbook, still has some months to go before the first candle on a birthday cake can be lighted.

This is how it all began. At the once-thriving port of colonial Alexandria, Va., was born the idea out of which grew the Penguin. A small group of Potomac River and Chesapeake Bay sailors, grown tired of caring for and racing larger boats, wrote during the winter of 1938-39 to the country's leading naval architects. From them, they wanted the plans of an able sailing dinghy, something around 12 feet and comparatively simple to build.

Out of the plans submitted, the group selected a 12-foot sliding *gunther* rig dinghy of batten seam construction. It was from the designing board of Phil Rhodes, famed designer of many a deep-water racing yacht. Keeping in mind simplicity and economy of construction, the Potomac River sailors requested and received from Designer Rhodes his redrafting of the dinghy to 11½ feet without the *gunther* rig. A chine bottom with only a slight arc answered the problems of building Penguins of plywood.

By the end of the 1939 season, twelve boats had cropped up on the Potomac. That same fall the Penguin's smart lines attracted the attention of Herbert L. Stone, editor of Yachting Magazine, who saw in the Penguin an answer to the growing demand for an able little racing dinghy.

With the publication of the Penguin plans in the May, 1940, issue of Yachting, the flood began. Requests for plans and additional information so swamped the magazine's offices the editors threw up their hands and issued a call for help from the group who began it all. It was time, all agreed, that a national class be organized. In the fall of last year the first national meeting was held in Alexandria. Officers were elected and a constitution and by-laws were adopted.

The Penguin had hatched from its shell and was beginning to feel its wings for the first time. Today those wings in increasing numbers are appearing wherever there exists the desire to get afloat in a smart sailer at a minimum cost.

Fleets continue to pop up in all sections of the country—there is even interest shown in the Penguin by yachtsmen of the Philippines. As this goes to press, fleets are in various stages of formation at Green Bay Yacht Club, Green Bay, Wisc.; Fremont Junior High School, Pomona, Calif.; Spokane, Wash.; Sea Cliff Yacht Club, Roslyn, L. I.; Maryland Yacht Club, Baltimore, Md.; Potapskut Sailing Association, Wall Cove, Md.; Indian Landing Boat Club, Millersville, Md.; Lake Washington Sailing Club, Sacramento, Calif.; Clear Lake Sailing Club, Upper Lake, Calif.; Mission Bay Yacht Club, Berkeley, Calif.; Wessagussett Yacht Club, North Weymouth, Mass.; Bay Head Yacht Club, Bay Head, N. J.; Urbanna Yacht Club, Urbanna, Va., and Rochester, N. Y.

At Seattle, Wash., alone there are 47 Penguins, one of the largest one-design fleet of sailboats in the United States. Racing there the past winter marked the first time in the Pacific Northwest that boats had participated in off-season competition. Highlight of the past winter season there, was races for the President's Cup, donated by Fleet Captain Charles Frisbie. Frostbite races also were held off the Manhasset Bay Yacht Club on Long Island Sound and off the Old Dominion Boat Club at Alexandria.

The class staged its first open regatta last September at Alexandria, Va., and Penguins from three States and the District of Columbia participated. Wisely, national officers have gone slowly on holding a national championship last year. Penguin owners, however, may look forward to such an event this year. The time and place will be announced to skippers at a later date.—Malcolm D. Lamborne, Jr.

THINGS YOU WANT TO KNOW

The designer of the Penguin plans has assigned all rights and title to the Penguin Class Dinghy Association, and plans may be purchased through the Secretary of the Association. The fee for plans is \$3.00, payable to the Treasurer of the Association. The plans themselves consist of lithographed prints of the lines and offsets, construction drawings, sail plan, detailed spar drawing, full size templates for all frames, stem and stern knees and centerboard trunklogs.

The Penguin Class Dinghy Association has no interest in, or affiliation with, any professional yacht builder, and the plans are available to amateur and professional builders alike. Several professional builders are offering Penguins complete and ready to sail, at prices from \$150.00 to \$200.00. Other builders are offering knockdown sets or parts in kit form to amateurs who prefer to assemble and finish their own boats.

The Association will refuse to issue a number or grant a measurement certificate to any boat on which the royalty has not been paid or which was not built from a recorded set of Penguin plans. A royalty or number tax of \$2.00 must be paid by the builder to the Association on each additional boat built from a set of plans. No boat may properly be sold, or entered in any race as a Penguin, or at any time display the Penguin Emblem upon its sails or otherwise, unless the number tax or royalty on such boat has been paid to the Association by the builder or owner thereof. For the benefit of owners, and prospective owners, the Association proposes to take whatever steps may be necessary to protect the name and Emblem from any unauthorized use.

CONSTITUTION

ARTICLE 1—Name
Penguin Class Dinghy Association.

ARTICLE 2—Emblem
The emblem shall be a black Penguin as shown on the official sail plan.

ARTICLE 3—Object
To promote and develop Penguin Class Dinghy racing under uniform rules governed by the Association, and to rigidly maintain the one design features of Penguin Class Dinghies.

ARTICLE 4—Policy
To keep the cost of construction, sails, and Association dues at a minimum in order that Penguins may be available to the largest number of owners, and to rigidly maintain a strictly one design class.

ARTICLE 5—Jurisdiction
The Association has jurisdiction over all Penguin Class activities. The Class Rules govern all sanctioned Penguin races, regardless of by whom held. The Constitution, By-Laws and Rules are binding upon all members and fleets, and all registered Penguin Class Dinghies must conform to the official plans and specifications.

ARTICLE 6—Membership
All owners and part owners of Penguin Dinghies are eligible to be active members of the Association. Active members have the following privileges: To hold office, to vote, and to skipper a Penguin Dinghy in sanctioned events, in accordance with the By-Laws.

Honorary members shall consist of those having rendered extraordinary service to the Association. They shall be elected by the Executive Committee, and shall have all privileges of an active member.

ARTICLE 7—Organization
The Association shall consist of individual members who shall belong to fleets, which in turn shall be organized into regions, the whole of which shall be under the jurisdiction of the Executive Committee.

PROCEDURE FOR MEASURING PENGUIN DINGHY

1. With boat right side up, measure its length from stem head to after side of transom (see measurement sheet).
2. Divide this measured length by 4.
3. Measure from the stern, and mark with chalk, the $\frac{1}{4}$, $\frac{1}{2}$ and $\frac{3}{4}$ length of the boat. (Sections A, B, C, D on sketch.)
4. Measure the beam of the boat (dimension Q) at sections A, B, C, D.
5. Turn the boat upside down and stretch tightly a chalk line (hard cotton string) located over the center of the boat and six inches above the stem and transom (see measurement sheet). This is most easily accomplished by firmly setting a light post up forward and aft, and adjusting the string to the height and centerline specified above.
6. Mark sections A, B and C on the boat by using a flexible batten and chalk or by snapping a chalk line. (This is done by running a hard cotton line thru chalk, stretching it tightly over the section to be marked, raising the center of the line and letting it snap back onto the section.)
7. Make the measurements described on the measurement sheet.
8. If there are any questions as to the methods of measuring, write the National Measurer, Mr. George A. Dankers, Jr., 3010 10th Street, North Arlington, Virginia.

MEASUREMENT REGULATIONS

1. Measurements shall be made by the owner, builder, or a measurer of a Yacht Club.
2. This measurement sheet shall be forwarded in duplicate to the National Measurer who shall approve or reject the boat as a class member accordingly if boat is within or beyond the building tolerances established by the ruling committee.

The registration of your boat is not complete until your Measurement Certificate has been approved by the National Measurement Committee. Only measured boats are permitted to race in sanctioned events.

3. Boats shall be subject to remeasurement as to dimensions and data on the measurement sheet upon protest. The person protesting shall post a bond of \$2.00 as evidence of good faith, which shall be used to pay the measurer if the measurements are in accordance with those on the boat's measurement sheet. If dimensions fail to check with those submitted on the measurement sheet, the bond shall be returned and owner shall pay remeasurement fee which shall not exceed \$2.00. Remeasurement shall be made by the measurer of the Yacht Club having control of the races, or a measurer appointed by the Race Committee having control of the races.


